| <p>Summary:</p> <p>In March 2021, the Home Office provided £3.37m to sustain the work of the Violence Reduction Unit (VRU) for another 12 months. It is intended that this will fund the VRU to work with all relevant agencies to support a multi-agency, public health, long-term approach to preventing and tackling serious violence.</p> <p>Part of the application submitted to the Home Office included proposals for interventions for 2021/22. The approach to commissioning and delivering the interventions were developed with partners. Proposals included a proportion of funding being made available to CSPs to commission locality based early interventions that support the local plan. A total of £443,893 was made available to for this (as outlined in the Home Office Delivery Plan).
